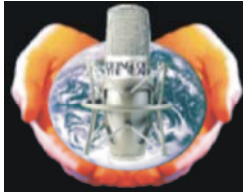

However, this song absolutely must have a full musical arrangement. The melodies are sharp and original and must serve as the backbone of your arrangement. Your production is very good.</p>
